WAGGA INQUIRY RESTARTS

The ABA has recommenced the inquiry started by Australian Broadcasting Tribunal into the grant of a commercial FM radio licence to serve the Wagga Wagga region of NSW.

The new service would cover Wagga Wagga, Tumut, Gundagai, Junee, Culcairn, Temora, Cootamundra, Coolamon, Lockhart and Narrandera.

This follows a successful appeal by the licensee of existing AM service 2WG (Riverina Broadcasters (Holdings) Pty Ltd), against the decision of the Australian Broadcasting Tribunal to grant a licence to Wagga and Riverina FM Stereo Broadcasters Pty Ltd.

The ABA replaced the Tribunal on 5

October 1992, under the new *Broadcasting Services Act 1992*. The Tribunal's decision in November last year would have given Wagga a second, independent commercial radio service.

The Federal Court set aside the decision and remitted it the Tribunal for further consideration after finding it had made an error of law in deciding to grant the licence to Wagga and Riverina FM.

ABA Member, Mr Tim O'Keefe, will now consider licence applications (which the ABA has asked to be updated) from Wagga and Riverina FM, as well as a submission opposing the grant lodged by Riverina Broadcasters. South West Media Ltd, an applicant for the licence, withdrew

from the inquiry on 22 December 1992.

The criteria against which applications for the Wagga inquiry will be considered include whether the applicant is a fit and proper person to hold the licence; has the financial, technical and management capabilities necessary to provide an adequate and comprehensive service; and is capable of complying with the conditions of the licence.

The public inquiry file, which includes all evidence previously considered during the former Tribunal inquiry and any updated information lodged with the ABA, is available for public inspection at the ABA's Sydney office and the Wagga Public Library.
