### ABA holds public hearing in Bathurst

The ABA held a public hearing in Bathurst on 17 November 1998 to assist it in allocating a new community radio licence in the Bathurst area.

The ABA received two applications for the licence, from Bathurst Christian Broadcasters Inc and Bathurst District and Community Radio Broadcasters Inc. The hearing was conducted by a panel constituted by Professor David Flint, ABA Chairman, and Mr Michael Gordon-Smith, ABA Member.

The ABA will now decide whether, and to whom, to allocate a community radio licence to serve Bathurst. In making its decision, the ABA will consider all the information and submissions provided during the allocation process, as well as any evidence provided at the hearing.

A public hearing file containing copies of the two applications is available for viewing at the Bathurst City Library, 70–76 Keppel Street, Bathurst. A copy of the ABA's *Guide to Community Licence Allocations*, including the relevant legislation, is also on the file.

#### Up to twenty new radio services proposed for south east NSW

The ABA is proposing to make channels available for up to twenty new radio services in the Illawarra and south east New South Wales. The region includes the radio markets of Bega, Cooma, Goulburn, Nowra and Wollongong.

As detailed in draft licence area plans, the ABA proposes to make channels available for a new commercial radio service in Wollongong, seven new community radio services and three new open narrowcasting radio services.

In a number of markets the ABA has identified vacant channels but not put forward a firm proposal as to what type of service it should make available. It is seeking input from listeners in those markets as to what sort of new services they would like.

In each of Cooma, Goulburn and Nowra, the ABA is seeking submissions on whether channels should be made available for either a new commercial radio service of an open narrowcasting service.

In Wollongong, the choice is between making an AM channel available for a second new commercial radio service or an open narrowcasting service. In each of Batemans Bay, Eden, Moruya, Narooma and Wollongong, the ABA is considering the option of either a community radio service or open narrowcasting service.

Capacity will also be reserved for five new national radio services.

There is interest in providing community radio services in Batemans Bay, Bega, Bowral, Eden, the Monaro area, Moruya, Moss Vale, Narooma, Ulladulla, and Wollongong.

There is interest in providing open narrowcasting radio services throughout the Illawarra and south east NSW, ranging from limited power tourist information services to high power racing radio services.

The ABA is calling for submissions on its options and draft licence area plans which are on the ABA's web site <www.aba.gov.au> and are available for viewing at libraries in Bega, Cooma, Nowra, Goulburn, Bowral and Wollongong.


#### Memorandum of understanding

## Daylight saving differences in broadcast times

The ABA has been advised that, since the start of daylight saving, some commercial television viewers in the Tweed Heads area of New South Wales are receiving broadcasts one hour later than usual.

These viewers receive their television signals from Queensland, rather than from NSW transmitters.

If viewers wish to receive these services in NSW time, they will need to redirect their aerials to either the Mt Nardi or Springbrook transmission sites.

This situation has arisen as a result of action taken by commercial television licensees serving this area, which overlaps the NSW/

Queensland border, to comply with the requirements of the code.

Earlier this year, an ABA investigation relating to the broadcast of programs into Queensland in 'NSW time' during daylight saving found that two of the three commercial television licensees serving this area were in breach of the code, in that they had broadcast 'M' classified movies in Queensland one hour earlier than permitted under the code. Those licensees then undertook to comply with the requirements of the code in future. Therefore, this year, broadcasts in Queensland occur one hour later than they do in NSW.

For the most part, this has not caused problems to viewers. However, in Tweed Heads, due to its proximity to the border and also its local topography, most television aerials take their signals from Queensland based transmitters.
