# Meet some of the ACCC health sector team

The Professions Unit was set up to give high priority to the conduct of business in the professions, health and medical sectors. The unit engages extensively with relevant organisations, and makes submissions to governments about professions issues. Claims about insurance coverage and other health-related goods and services have attracted Commission attention.



#### Sitesh Bhojani, Commissioner

Sitesh Bhojani has been with the ACCC as a Commissioner since November 1995 when the ACCC was created.

Before this, Sitesh, who holds a Bachelor of Science and Bachelor of Laws from Monash University, was a barrister with a general commercial and civil litigation practice at the independent Bar in Western Australia.

He has also held the positions of Associate Commissioner of the Trade **Practices Commission and Deputy** Chairman of the Law Council of Australia, Business Law Section's trade practices committee.

From 1986 to 1992 he was a barrister and solicitor with the Commonwealth Attorney-General's Department, Perth office and the Trade Practices Unit of the Australian Government Solicitor.
