AALL ANNUAL MEETING

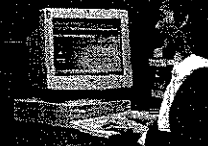
The Annual Meeting of the Association of American Law Librarians was held 15-20 July in Philadelphia. Some of the papers may be found on the *law.com* site
