AUSTRALIAN CASE LAW ON THE INTERNET

When searching for Australian case law one finds that most links lead to AustLII. However, SCALEplus also provides access to High Court and Supreme Court cases (except for Western Australia), and covers some Commonwealth courts AustLII offers access courts than **SCALE**plus to more sometimes SCALEplus offers better coverage of cases from particular courts. For example, AustLII covers the Defence Force Discipline Appeal Tribunal cases from 1999 onwards whereas SCALEplus offers coverage from 1986 onwards (currently 13 cases). AustLII (http://www.austlii.edu.au) and SCALEplus (http://scaleplus.law.gov.au) are the places to check but not always the only sites worth checking for free access to full-text cases.

Many of the sites which claim to have case law merely ink to the relevant page on

AustLII or SCALEplus. However, New South Wales and Queensland have set up their own case databases. For New South Wales, LawLink at http://www.lawlink.nsw.gov.au/ should be bookmarked. Select 'Caselaw NSW' from the menu and you will be able to access cases held in NSW courts from 1999 onwards. The Queensland web site Courts http://www.courts.qld.gov.au/qjudgment/defau lt.htm provides Queensland case law from January 2000 in pdf. The Queensland Law Society Inc web site provides links to all three main resources for Queensland case law: AustLII, SCALEplus and the Queensland The Society's web site is at Courts. http://www.qld.com.au/library/links.htm#qld-case.

The following table lists Australian case law which is currently available via Internet sites. Commercial sites are not listed as not everyone will have access to them The URLs will take you straight to the case law section of that web site, except for LawLink and the Queensland Courts URLs which will take you to the list of courts. There is such variability in what is available that I cannot make meaningful generalisations beyond recommending that if the case you want is not a Commonwealth or Supreme Court case, check the table and go straight to the case.
