### **Administrative Review Council**

The term of appointment of Mr Fulton Muir AO to the Council expired on 27 April 1992. He has served 2 terms on the Council.

Mr Christopher Conybeare, Secretary to the Department of Immigration, Local Government and Ethnic Affairs, was re-appointed to the Council on 27 March 1992.

Mr Alan Rose, Secretary to the Attorney-General's Department, was re-appointed to the Council on 7 May 1992.

Professor Helen Nugent was appointed to the Council on 7 May 1992. She is Professor in Management and Director of the MBA program at the Australian Graduate School of Management (UNSW).
