Sulphur Dioxide and Nitrogen Dioxide Exposure

We represent a worker who was exposed on a number of occasions to fugitive emissions of sulphur dioxide and nitrogen dioxide at a power station. We understand that the contaminants of sulphur oxide and nitrogen oxide are present in the flue gas, a by-product of fossil fuel power generation.

We need to retain a person to provide expert opinion and to give evidence in due course so far as exposure limits, probability of injury, sensitisation, cumulative damage etcetera are concerned.
