WORKMEN'S COMPENSATION (RATES OF COMPENSATION)
REGULATIONS 1982

1. CITATION

These Regulations may be cited as the *Workmen's Compensation (Rates of Compensation) Regulations 1982*.

2. COMMENCEMENT

These Regulations shall be deemed to have come into operation on and to have applied from 1 July 1982.

3. DEFINITION

In these Regulations, "Act" means the *Workmen's Compensation Act* as in force immediately before 1 July 1982.

4. AMENDMENT OF SECTION 10(1) OF THE ACT

Section 10(1) of the Act is amended by omitting "\$31,640" and substituting "\$36,987".

 - (g) by omitting from paragraph (1A)(b)(i)D "\$12.71" (twice occurring) and substituting "\$14.85";
 - (h) by omitting from paragraph (1A)(b)(i)E "\$12.71" and substituting "\$14.85";
 - (j) by omitting from paragraph (1A)(b)(i)F "\$12.71" and substituting "\$14.85";
 - (k) by omitting from paragraph (2)(a)(ii) "\$5,885.04" and substituting "\$6,879.61"; and
 - (m) by omitting from paragraph (8A) "\$1,271.25" (twice occurring) and substituting "\$1,486.09".
