BRITISH FOOD PRODUCTION ACT AMENDMENT ACT 01 1950.

[Assented to 30th November, 1950.]

• E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as "The Queensland-Short title British Food Production Act Amendment Act of 1950," and construction and shall be read as one with *"The Queensland-British Food Production Act of 1948," herein referred to as the Principal Act.

The Principal Act and this Act may be collectively Collective cited as "The Queensland-British Food Production Acts, title. 1948 to 1950."

2. Subsection two of section twenty of the Principal Amendment Act is amended by adding thereto the following of s. 20 (2). paragraph, namely :---

"Subject to the Corporation making payment as prescribed by this subsection, all improvements as defined in section four of †" The Land Acts, 1910 to 1949," upon any land so acquired (whether before or after the passing of ‡"The Queensland-British Food Production Act Amendment Act of 1950") shall become and be the property of the Corporation."

3. Subsection three of section twenty-three of the Principal Act is amended by repealing paragraph (ii.) thereof, and by inserting the following paragraph in lieu of that repealed paragraph, namely:-

> "(ii.) Six hundred and twenty-five thousand pounds Australian."

) E it enacted by the King's Most Excellent Majesty. by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:-

1. (1.) This Act may be cited as "The Queensland-British Food Production Acts Amendment Act of 1951," construction. and shall be read as one with *" The Queensland-British Food Production Acts, 1948 to 1950," herein referred to as the Principal Act.

> The Principal Act and this Act may be collectively cited as "The Queensland-British Food Production Acts, 1948 to 1951."

(2.) This Act shall come into operation on the first Commencement of this day of April, one thousand nine hundred and fifty-one. Act.

Amendment of s. 3.

2. Section three of the Principal Act is amended repealing therein the definition "Overseas Food by Corporation ".

Amendments of s. 4.

3. Section four of the Principal Act is amended—

(a) By repealing the word "subsection" where that word appears in subsection two of that section and by inserting, in lieu of that repealed word, the word "section".

" Overseas the (b) By repealing words Food Corporation "where those words appear twice in subsection three of that section and by inserting, in lieu of those words where so repealed, the words "Minister of Food of the United Kingdom ".
