# GRAIN INDUSTRY REGULATION 1994

## **1 Short title**

This regulation may be cited as the *Grain Industry Regulation 1994*.

## **2 Appointment of dissolution date (s 12 of the Act)**

The date for the dissolution of the merger participants is 4 February 1994.

## **3 Declaration of meaning of grain (s 3 of the Act)**

The meaning of “**grain**” includes cottonseed.
