An Act to enable the holders of certain pastoral Leases to come under the provisions of the "Waste Lands Amendment and Procedure Act, 1869-70."

[Assented to, 27th November, 1872.]

WHEREAS it is expedient to extend the time within which the Preamble. lessees of the Waste Lands of the Crown comprised in the leases specified in the First Schedule hereto, may apply for and obtain new leases under the provisions of Section 31 of the "Waste Lands Amendment and Procedure Act, 1869-70," and to provide that the holders of the leases specified in the Second Schedule hereto, shall have the privileges and advantages hereinafter expressed—Be it therefore enacted, by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said Province, in this present Parliament assembled, as follows:

1. Any of the lessees of any of the waste lands comprised in the Extension of time for lessees to give notice leases specified in the first Schedule hereto, who have neglected to of desire to obtain apply for leases within two months from the passing of the "Waste fresh leases. Lands Amendment and Procedure Act, 1869-70," as provided by the thirty-first section of that Act, and who shall, within two months from the passing hereof, make such application, shall be entitled to have leases issued to them in the like manner as they would have been entitled had they so applied within the time by such section limited.

2. The Fifth Schedule to the "Waste Lands Amendment and Alterations of Procedure Act, 1869-70," shall be read and construed as if such of

The Pastoral Lessees Relief Act.—1872,

the lands as are comprised in the several leases mentioned in the Second Schedule hereto, which are situate in District A described in the said Fifth Schedule, were situate in District B described in the said last-mentioned Schedule, and as if such of the lands as are comprised in the said several leases, which are situate in the said District B, were situate in District C described in the said last-mentioned Schedule.

Short title.

3. This Act may be cited for all purposes as "The Pastoral Lessees Relief Act."
