By His Excellency SIR WILLIAM THOMAS DENISON, Knight, Lieutenant-Governor of the Island of Van Diemen's Land and its Dependencies, with the Advice of the Legislative Council.

AN ACT for the general Appropriation of the Revenue for the Year One thousand eight hundred and forty-eight.

W HEREAS by the Act of this Island passed on the second day of January one thousand eight hundred and thirty-four for confirming and continuing certain Duties of Customs and Duties on Spirits it was enacted that the several Duties by that Act imposed (subject to the payment of the Salaries of the Lieutenant-Governor and of the Judges as by law in that behalf provided) should be thereafter applied in such manner and to such purposes as by any Act or Acts thereafter passed for the Appropriation of the Revenue should be appointed—AND WHEREAS it is expedient that all other the Colonial Revenue should in like manner be from time to time appropriated by Legislative Authority—

AND WHEREAS certain payments have been made for the year one thousand eight hundred and forty-eight for the several purposes hereinafter specified under and by virtue of certain warrants or orders in writing under the hand of His Excellency the Lieutenant-Governor and it is expedient to give effect to the same in the manner hereinafter provided—that is to say—

First—For defraying the charge of the Civil Establishment of this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of twenty-six thousand three hundred and eighty-nine pounds ten shillings and nine pence.

Secondly—For defraying the charge of the Department of Public Works in this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of fifteen thousand five hundred and twenty-nine pounds three shillings and seven pence.

THIRDLY—For defraying the charge of the Judicial Establishment of this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of thirteen thousand four hundred and eighty pounds one shilling. FOURTHLY—For defraying the charge of the Ecclesiastical Establishment of this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of twelve thousand four hundred and twenty-two pounds nine shillings and eleven pence.

FIFTHLY—For defraying the charge of the Education Establishment of this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of five thousand six hundred and sixty-eight pounds three shillings and five pence.

Sixthly—For defraying the charge of the Police and Gaols Establishments of this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of thirty-seven thousand two hundred and eighty-nine pounds twelve shillings and two pence.

Seventhly—For defraying the charge of the Agent-General in London for this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of two hundred pounds.

EIGHTHLY—For defraying the charge of Pensions payable out of the Colonial Revenue for the said year one thousand eight hundred and forty-eight the sum of six hundred and seventy-six pounds thirteen shillings and three pence.

NINTHLY—For defraying the charge for Pauperism in this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of four thousand and seventy-two pounds seventeen shillings and six-pence.

TENTHLY—For defraying the charge of Miscellaneous Services in this Island and its Dependencies for the said year one thousand eight hundred and forty-eight the sum of five thousand six hundred and twenty-one pounds fourteen shillings and nine pence.

ELEVENTHLY—For defraying the amount of Sundry Payments for the service of one thousand eight hundred and forty-seven paid subsequently to January one thousand eight hundred and forty-eight the sum of four thousand nine hundred and twenty-two pounds fourteen shillings and eleven pence.

BE IT THEREFORE ENACTED that the several payments so made shall be allowed in the accounts of the Treasurer and that the receipt or receipts of the respective parties to whom the same have been paid shall be a full and valid discharge to the said Treasurer on passing his accounts for any such sum or sums of money as shall have been therein mentioned and expressed to be received and that he shall and do receive credit for the same accordingly.
