AN ACT to regulate the Slaughtering and Sale of Cattle Sheep and Pigs in the Town of Launceston and the Suburbs thereof. [3rd October 1854.]

PREAMBLE.

W HEREAS an Act of Council or Ordinance of this Island was passed in the tenth year of the reign of His Majesty King George the Fourth intituled An Act to regulate the Slaughtering of Sheep and Cattle—And whereas a certain other Act of Council or Ordinance of this Island was passed in the seventh year of the reign of Her present Majesty Queen Victoria intituled An Act to regulate the Slaughtering of Sheep and Cattle imported into this Colony and the Sale thereof and to prevent the Sale of unwholesome Meat-And whereas it is expedient that the said recited Acts so far as respects the Town of Launceston and the suburbs thereof should be repealed and that provision should be made for the slaughtering and sale of Cattle Sheep and wigs in the said Town and suburbs in the manner hereinafter mentioned—And whereas the Lieutenant-Governor was lately pleased to appropriate for the use of the said Town of Launceston as a place for landing and depasturing imported cattle and for other purposes all that tract piece or parcel of land situate lying and being on the Launceston Swamp in the County of Dorset in Van Diemen's Land containing by admeasurement sixteen acres three roods twenty-four perches or thereabouts and bounded on the south east by fifteen chains thirty-four links north-easterly along Gleadow-street from its angle with the Esplanade on the north east by ten chains northwesterly along Henty-street on the north west by eighteen chains fifty links south-westerly to the Esplanade aforesaid and on the south east by the Esplanade to the point of commencement—Be it enacted by His Excellency Sir William Thomas Denison Knight Lieutenant-Governor of the Island of Van Diemen's Land and its Dependencies with the advice and consent of the Legislative Council as follows:-

I. On from and after the day when this Act shall come into Repeals 10 Geo. 4, operation the said recited Acts of Council or Ordinances of this Island No. 4. and 7 Vict. so far as respects the said Town of Launceston and the suburbs thereof No. 17. shall be and the same are hereby repealed excepting always as to all or any offences committed or matters or things done before that day all which offences matters and things shall be dealt with as if this present Act had not been passed.

II. For the purposes of this Act the piece or parcel of land herein- Landappropriated before described shall be and the same is hereby declared to be and to form part of form part and parcel of the suburbs of the said Town and the Mayor Town. for the time being of the said Town or any other Justice or Justices of the Peace in and for the said Island shall for such purposes have full power jurisdiction and authority in and over all offences committed and matters or things done or omitted to be done within the said suburbs.

III. This Act shall commence and take effect when and so soon as any Commencement of public slaughter-house shall be declared and appointed as hereinafter Act. mentioned and all matters and things hereinafter by this Act directed or authorised to be done or prohibited from being done shall be deemed and taken to be and shall be so directed and authorised or prohibited on from and after that day accordingly.

IV. When and so often as any public slaughter-house shall be Slaughter-house appointed as hereinafter mentioned for the Town of Launceston afore- and materials said every such public slaughter-house and the materials thereof and all thereof to be the implements of what nature or kind soever books stationery office furniture and Aldermen. offices the land whereon the same slaughter-house shall be erected and the appurtenances thereunto belonging shall for the purposes of this Act be deemed and taken to be and shall be the property of the Mayor and Aldermen for the time being of the Town of Launceston aforesaid.

V. Every person who on from or after the day aforesaid shall Penalty for slaughter or cause to be slaughtered any cattle sheep or pig or shall slaughtering cattle sell or cause to be sold any meat being the carcass or part of the carcass or selling meat of any cattle sheep or pig within the said Town of Launceston or the suburbs thereof without having obtained a proper annual licence (the duration of which licence shall without reference to the time when granted be until the first day of November next ensuing the date thereof and no longer) from the Mayor for the time being of the said Town who is hereby authorised and required to grant such licence under his signature in the form or as near thereto as may be in the Schedule to this Act annexed marked A which is hereby declared to be and made part and parcel of this Act and to charge and receive for the same the sum of One Pound shall forfeit and pay a penalty or sum not exceeding Fifty Pounds-Provided always and it is hereby declared that Existing licences from and after the date of this Act coming into operation the licence of to cease. every person and persons within the said Town which may have been granted as by the first section of the said firstly recited Act is mentioned shall wholly cease and be void anything in such licence or in the said firstly-recited Act to the contrary contained in anywise notwithstanding 18 Vict. without licence.

—Provided also that nothing herein contained shall prevent persons from killing pigs for sale on their own premises elsewhere than in the Town of Launceston or the suburbs thereof or from selling the carcases thereof without obtaining or taking out such licence as aforesaid.

Mayor may appoint public slaughter-houses for Launceston.

Penalty for slaughtering elsewhere than at such slaughterhouses. VI. It shall be lawful for the Mayor of the said Town, and he is hereby authorised and empowered from time to time by any notice under his hand for that purpose made and published in the Hobart Town Gazette and in any one or more of the local newspapers to declare and appoint one or more public slaughter-house or slaughter-houses (for the slaughtering therein of cattle sheep or pigs) for the said Town of Launceston—And if any person shall after such slaughter-house shall have been so declared and appointed for the said Town of Launceston slaughter or cause to be slaughtered any cattle sheep or pig in the said Town of Launceston or within one mile of the boundaries thereof excepting in such public slaughter-house so declared and appointed for the said Town such person shall for every head of eattle sheep or pig so slaughtered or caused to be slaughtered as aforesaid forseit and pay a penalty or sum not exceeding Twenty Pounds.

Mayor and Alder men may borrow money for the purpose of erecting public slaughterhouses.

VII. It shall be lawful for the Mayor and Aldermen for the time being of the said Town of Launceston and they are hereby authorised and empowered from time to time to borrow and take up at interest such sum or sums of money as shall by such Mayor and Aldermen be deemed requisite and sufficient for the purpose of erecting and constructing any building so to be declared and appointed as any such public slaughter-house as aforesaid for fitting up the same and the providing of all necessary and proper materials and things required for the same and to arrange for the payment of the interest on any such sum or sums of money so borrowed and to secure the repayment of any such sum or sums of money in such manner and by such ways and means as to such Mayor and Aldermen shall seem most expedient and such Mayor and Aldermen are hereby authorised and empowered to cause any such public slaughter-house to be erected constructed and fitted up in such manner and all such materials matters and things to be provided for the same as to such Mayor and Aldermen shall seem meet.

And may erect such slaughterhouses in such manner as to them shall seem meet.

Mayor and Aldermen to appoint persons to manage slaughter-houses and make Rules for the conduct thereof and other purposes.

VIII. It shall be lawful for the said Mayor and Aldermen and they are hereby empowered from time to time to nominate and appoint during pleasure an Inspector of Stock and all proper and suitable officers and persons who shall be required to conduct manage and supervise any such public slaughter-house which shall be so declared and appointed as aforesaid and by any order or writing under their hands to be for that purpose made and published in the *Hobart Town Gazette* and in any one or more of the local newspapers to issue such Bye-laws Rules Orders and Regulations for the proper ordering conduct management and cleansing of any such public slaughter-house as aforesaid or for or in respect of the landing from any steam-boat ship or vessel of any live or dead cattle sheep or pig as hereinafter mentioned as to such Mayor and Aldermen shall seem requisite and desirable and any person who shall neglect or refuse to obey or comply with or who 18 Vict. shall in any manner disobey or infringe any such Bye-law Rule Order or Regulation as last aforesaid shall be guilty of an offence against this Act and shall for every such offence if not otherwise provided for in this Act forfeit and pay a penalty or sum not exceeding Fifty Pounds.

IX. It shall be lawful for the Mayor and Aldermen for the time Mayor and Alderbeing of the said Town of Launceston by any writing under their men to fix rates hands to be for that purpose made and published as aforesaid from time to be paid for slaughtering cattle to time to fix and declare the rates or sums which shall be paid by &c. at public every person for the slaughtering at any such public slaughter-house slaughter-houses. as aforesaid of any cattle sheep or pig and any person who shall slaughter any cattle sheep or pig at any such public slaughter-house as aforesaid shall before the same shall be so slaughtered at such public slaughter-house and every such person is hereby required so to do pay such rates or sums so for that purpose for the time being fixed and declared as aforesaid to such person as shall by the said Mayor and Aldermen be from time to time for that purpose appointed.

X. If after any such public slaughter-house as aforesaid shall have Penalty for been so declared and appointed for the said Town of Launceston as bringing meat for hereinbefore provided any person shall bring or cause to be brought sale into or selling into the same Town or within one mile of the boundaries thereof any meat in Launces-ton not having meat intended for sale being the carcass or any portion of the carcass been slaughtered of any cattle or sheep which shall not have been killed in any such in a public public slaughter-house so declared and appointed for the said Town or slaughter-house. shall sell or offer or expose for sale or shall cause to be sold or offered or exposed for sale in the said Town or within one mile of the boundaries thereof any meat being the carcass or any portion of the carcass of any cattle or sheep which shall not have been killed in any such public slaughter-house as aforesaid every such person so offending shall forfeit and pay a penalty or sum not exceeding Fifty Pounds,

XI. XIII. No person shall convey or cause to be conveyed on board any steam-boat ship or other vessel in the Port or Harbour of Launceston aforesaid any cattle sheep or pig except at such place and at such time and in such manner and subject to such Rules and Regulations as shall from time to time by any order or writing for that purpose made and published in the Hobart Town Gazette and in any one or more of the local newspapers be by the Mayor and Aldermen for the time being of the said Town fixed directed and determined upon— And no person shall carry or cause to be carried on board any steam-boat ship or other vessel in the port or harbour of the said Town any cattle sheep or pig without giving sufficient notice of such person's intention so to do to the Inspector of Stock for the said Town so as to enable such Inspector of Stock to inspect such cattle sheep or pig before the embarkation thereof and without giving opportunity and permission to such Inspector of Stock so to inspect such cattle sheep or pig and if any person shall convey or cause any cattle sheep or pig to be conveyed on board any steam-boat ship or other vessel except at such place at such time and in such manner as aforesaid or without giving such notice to such Inspector of Stock and such opportunity and permission to inspect the same as aforesaid or shall refuse or neglect to give to the Inspector of Stock for the said Town immediately upon being by him requested so to do the Christian and surnames and residences as well of the owner or owners of such cattle sheep or pig as of the person or persons from whom such person so conveying or causing the same to be conveyed every such person so offending shall forfeit and pay a penalty or sum not exceding Fifty Pounds.

Inspector of Stock to trace or recognize the same—And if any person shall not so yard any such cattle sheep or pig so as to enable such Inspector of Stock properly and effectually to inspect the same or shall obstruct or refuse to permit any such branding or otherwise marking of any such cattle sneep or pig by such Inspector every such person so Penalty for not offending shall forfeit and pay a penalty or sum not exceeding Twenty yarding or for Pounds.

XV. It shall be lawful for the said Inspector of Stock on inspect- Fees payable to ing any cattle sheep or pig in pursuance of any notice for that Inspector. purpose given by virtue or under the authority of this Act to demand and receive from the person giving such notice as aforesaid for inspecting each head of cattle the sum of Sixpence and no more and for inspecting each score of sheep or pigs the sum of Ten-pence and no more and so in proportion for a less number of sheep or pigs and if any such person shall not immediately upon demand being made pay the amount of such charges as aforesaid to the Inspector of Stock for the said Town every such person so offending shall over and above the amount of such charges forfeit and pay a penalty or sum not exceeding Five Pounds.

XVI. If any person shall slaughter or cause to be slaughtered for Penalty for the purposes of sale any cattle sheep or pig in a sickly or diseased slaughtering diseased entitle state. state or shall sell or offer or expose for sale or cause to be sold eased cattle &c. or offered or exposed for sale the flock of one cause to be sold and selling unor offered or exposed for sale the flesh of any such animal or any wholesome meat. putrid or unwholesome meat whatsoever then and in every such case every such person so offending shall for every such offence forfeit and pay a penalty or sum not exceeding Fifty Pounds.

XVII. It shall be lawful for the Mayor or any Alderman for the Unwholesome time being of the said Town or for any Justice of the Peace or any Chief meat exposed for Chief District or District Constable or the Inspector of Stock for the sale may be seized said Town or the Town Inspector of the same Town either alone or attended by any Constable or other Officer to enter into any house shop shambles or other place where any such flesh or meat as last aforesaid shall be offered or exposed for sale and to seize take away and destroy all such flesh or meat as last aforesaid and if any person shall resist or obstruct any such Mayor Alderman or Justice of the Peace Chief Chief District or District Constable Inspector of Stock Town Inspector or other Constable or Officer as aforesaid in entering into any such house shop shambles or other place as aforesaid or in seizing taking away or destroying any such flesh or meat as last aforesaid every such person so offending shall forfeit and pay a penalty or sum not exceeding Twenty Pounds,

XVIII. If upon any such inspection of any cattle sheep or pig or of any carcass or any portion of any carcass of any cattle sheep or pig by the said Inspector of Stock for Launceston the same shall appear to such Inspector of Stock to be unfit for human food it shall be lawful for such Inspector of Stock and he is hereby empowered to seize take away kill and destroy the same as the case may be and if any person shall resist or obstruct the said Inspector of Stock in so seizing or taking away or killing or destroying as the case may be any such cattle sheep or pig or any such carcass or any such portion of any carcass of any cattle sheep or pig every such person so offending shall forfeit and pay a penalty or sum not exceeding Twenty Pounds - Provided always that if the owner of any such cattle sheep or pig or of any such carcass or of any such portion of any carcass of any cattle sheep or pig or any person on behalf of such owner shall object to such cattle sheep or pig or such carcass or such portion of any carcass as aforesaid so being seized as aforesaid on the ground that the same is unfit for human food the said Inspector of Stock shall forthwith submit the same to some Alderman or Justice of the Peace for this Island and if such Alderman or Justice of the Peace shall determine that such cattle sheep or pig or such carcass or such portion of any carcass is unfit for human food it shall be lawful for the said Inspector of Stock so to take away kill or destroy the same as the case may be and not otherwise—Provided always that it shall in case owner objects any case be lawful for the said Inspector of Stock to permit and suffer the tallow or fat to be separated from the carcass of any such cattle sheep or pig under the immediate inspection of and subject to such restrictions as shall for that purpose be prescribed by such Inspector of Stock.

> XIX. If any person licensed as by this Act is provided shall put place or throw or shall cause or suffer to be put placed or thrown or shall wrongfully permit or suffer to remain any skin offal horn or blood or other part whatsoever of any animal in or on any public street or place or in or on his or her own premises or any other place whatsoever where the same shall occasion or be likely to occasion public annoyance every such person so offending shall forfeit and pay a penalty or sum not exceeding Twenty Pounds.

> XX. If the Inspector of Stock for the said Town shall have reasonable cause of suspicion that any cattle sheep or pig he is inspecting has been stolen it shall be lawful for such Inspector of Stock and he is hereby empowered to seize and detain such cattle sheep or pig as aforesaid and the said Inspector of Stock is hereby directed forthwith to report such seizure and the grounds thereof to the Mayor or some Justice of the Peace for this Island residing in the said Town of Launceston who shall thereupon make such order in the matter as the justice of the case may require.

> XXI. It shall be lawful for any Justice of the Peace or any Chief Chief District or District Constable or the Town Inspector or the Inspector of Stock for the said Town either alone or attended by any Constable or other Officer to enter and search the house or premises of any person licensed as by this Act provided at any hour by day or 18 Vict. XXIII. XXIV. No person shall keep or maintain any establishment or place Penalty for for the purpose of boiling down cattle sheep or pigs or in which cattle skeeping a boiling-down establishment in Launwithin one mile of the boundaries thereof and if any person shall keep ceston. or maintain or cause to be kept or maintained any such establishment or place as aforesaid within the said Town or such distance thereof as aforesaid every such person so offending shall forfeit and pay a penalty or sum not exceeding Twenty Pounds for each and every day the same shall be so kept or maintained as aforesaid-And if any person shall Penalty for boil down or do any act in or towards the boiling down or cause to be boiled down or cause any act to be done in or towards the boiling down Launceston. of any cattle sheep or pig or any portion thereof within such Town or such distance thereof as aforesaid every person so offending shall for every animal or portion thereof so boiled down or in or towards the boiling down of which any act shall be so done as aforesaid forfeit and pay a penalty or sum not exceeding Five Pounds.

XXV. No public sale by auction of any cattle shall be had or held Penalty for selling at any place within the said Town other than some yard adjoining auction except at and belonging to a public slaughter-house to be declared and appointed places appointed as aforesaid and any person or persons so offending shall for every such for that purpose. offence forfeit and pay a penalty or sum not exceeding Twenty Pounds. 18 Vict. Persons acting under this Act may plead the general issue. XXVI. If any action or suit shall be brought against any Inspector of Stock for the said Town or any other person acting in the execution of his duty under this Act such Inspector of Stock or other person acting as aforesaid may plead the general issue and give this Act and the special matter in evidence and if the plaintiff shall be nonsuited or shall discontinue his or her action or a verdict shall pass against such plaintiff or judgment shall be had for the defendant upon demurrer the defendant shall be entitled to treble costs.

Proceedings for penalties &c.

XXVII. Any breach whatsoever of any or either of the provisions of this Act for which any pecuniary penalty is imposed or any breach whatsoever of any Bye-law Rule Order or Regulation to be made and published by the Mayor and Aldermen of the said Town by virtue of this Act as aforesaid shall be deemed and taken to be an offence against this Act and where no other mode or remedy is by this Act specifically provided all offences against this Act shall upon information in that behalf exhibited be heard and determined by and before the Mayor of the said Town or any other Justice or Justices of the Peace in the mode prescribed by the Act of this Island intituled An Act to regulate Summary Proceedings before Justices of the Peace and all fines penalties and forfeitures imposed or incurred by or under this Act shall except as aforesaid be levied and recovered in the manner prescribed by the said lastly-recited Act and shall go and be applied in the manner hereinafter set forth or directed concerning the same.

Appropriation.

XXVIII. All monies payable under or by virtue of this Act and all fines payable in respect of offences against this Act shall severally be from time to time paid into the hands of the Town Clerk for the time being of the said Town of Launceston and shall be by the Mayor and Aldermen for the time being of the same Town appropriated and applied in the first place towards the payment of the interest on any sum or sums of money which shall be so borrowed as by this Act is provided in the next place towards the erection improvement support and maintenance of any such public slaughter-house which shall be so declared and appointed as by this Act is provided the defraying of all charges and expenses connected therewith and the payment of all or any expenses which shall be occasioned by carrying the several provisions in this Act into effect and in the next place towards the repayment of any principal sum or sums of money which shall be so borrowed as aforesaid and the surplus if any shall be by the said Mayor and Aldermen appropriated and applied in or towards the paving lighting and cleansing or otherwise improving the said Town—Provided always that all monies which shall be so paid to the said Town Clerk as aforesaid shall forthwith be by him deposited in one of the public Banks of the said Town to the account of the said Mayor and Aldermen and no part of such moneys shall be drawn out of any such Bank except by an order signed by the Mayor of the said Town and countersigned by one Alderman and the Town Clerk of the

Interpretation.

XXIX. The term "Town Inspector" as used in this Act shall be held and construed to intend and mean every person for the time being acting 18 Vict. No. 7.

as Town Inspector for the said Town of Launceston and the term "Inspector of Stock" as used in this Act shall be held and construed to intend and mean every person for the time being acting as an Inspector of Stock for the said Town and the term "cattle" as used in this Act shall be held and construed to intend and mean any bull bullock cow steer heifer or calf and the term "sheep" as used in this Act shall be held and construed to intend and mean any ram ewe wedder or lamb and the term "pig" as used in this Act shall be held and construed to intend and mean any boar sow or barrow pig and the said terms "cattle sheep or pig" shall in every case be construed and understood to import either the singular or the plural number as the sense or nature of the context may require.

SCHEDULE A.

WHEREAS under and by virtue of the provisions of the Act of Council of this Island intituled An Act to regulate the Slaughtering and Sale of Cattle Sheep and Pigs in the Town of Launceston and the Suburbs thereof A. B. of hath applied to me W. S. B. Mayor of the said Town for a Licence to sell Meat at his [or her] house situate in and also to slaughter Cattle Sheep and Pigs and hath paid to me the said W. S. B. the sum of One Pound being the Fee by the said recited Act directed to be paid for any such Licence. I the said W. S. B. do therefore in pursuance of the said recited Act grant to the said A. B. this Licence to sell Meat at his [or her] house situate in and not elsewhere and also to slaughter Cattle Sheep and Pigs which shall continue in force from the date hereof until the day of now next ensuing and no longer.
