AN ACT to provide for the Application of certain  
Moneys granted to this State by the Commonwealth  
in Aid of the Mining Industry.

[16 November, 1936.]

WHEREAS by the *Appropriation (Unemployment Relief) Act 1936* of the Commonwealth, certain moneys were granted to this State in respect of the financial years ending respectively on the thirtieth day of June, one thousand nine hundred and thirty-seven, and the thirtieth day of June, one thousand nine hundred and thirty-eight, upon the conditions set forth in subsection (2) of section three of that Act, to be used by the State in providing, for the purpose of relieving unemployment, assistance to the metalliferous mining industry :

Preamble.

And whereas it is desirable to make provision for the application of the moneys so granted in respect of the financial year first aforesaid :

*Aid to Mining (Federal Grant).*

A.D. 1936. Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title. **1** This Act may be cited as the *Aid to Mining (Federal Grant) Act 1936*.

Interpretation. **2** In this Act—  
 “The Commonwealth Act” means the *Appropriation (Unemployment Relief) Act 1936*, of the Commonwealth;  
 “The trustees” means the Minister, the Commonwealth Sub-Treasury Accountant at Hobart, and the Secretary for Mines.

Trust account. **3**—(1) For the purposes of this Act there shall be kept in the books of the Treasury a trust account to be called “The Aid to Mining (Federal Grant) Trust Fund 1936-37.”

Application of moneys granted for 1936-37. (2) All moneys received by this State under the provisions of the Commonwealth Act for the purposes mentioned in the first schedule to that Act in respect of the financial year ending on the thirtieth day of June, one thousand nine hundred and thirty-seven, shall be paid into and credited to the said account.

(3) The moneys standing to the credit of the said account shall be paid and applied by the Treasurer, on the certificate of the trustees, for the purposes approved by the Treasurer of the Commonwealth, and as provided by the subsection (2) of section three of the Commonwealth Act.

(4) This section shall be deemed to have come into operation on the twenty-third day of September, one thousand nine hundred and thirty-six.

Retrospective amendment of 25 Geo. V. No. 92. **4** The *Aid to Mining (Federal Grant) Act 1934* is hereby amended as from the commencement thereof—

- i. By deleting “conditionally” to “Act” in subsection (1) of section three thereof;
- ii. By expunging subsection (2) of the said section; and
- iii. By deleting “(1)” at the beginning of the section.

Regulations. **5** The Governor may make regulations for the purposes of this Act.
