AN ACT to authorise the Corporation of the City of Hobart to borrow an amount not exceeding Three hundred and seventy-two thousand five hundred Pounds for certain purposes. [14 July, 1944.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Hobart Corporation (Loans) Act 1944*.

(2) This Act shall be incorporated and read as one with the *Hobart Corporation Act 1929** and the *Hobart Corporation Act 1930*†.

Hobart Corporation (Loans).

Power to
borrow for

purposes.

2 It shall be lawful for the Corporation to borrow and take up at interest, on the security of the whole of the revenues of the Corporation, such sums of money as the Corporation deems necessary for the purposes hereinafter set forth, not exceeding, in each case, the amount hereinafter specified in respect of each purpose—

- (a) for constructing, reconstructing, improving, extending, re-aligning, and widening the streets of the city in such manner as the council may deem necessary, £150,000;
- (b) for augmenting, improving, and extending the sewerage system of the city, and generally for the purposes of the *Hobart Sewerage Acts 1898-1932**, £40,000;
- (c) for the provision of additional land, premises, and equipment for reserves and recreation grounds under the control of the council and for the improvement thereof, £20,000;
- (d) for the improvement and extension of the tramway service in the city and suburbs, and generally for the purposes of the *Hobart Corporation Tramways Act 1912†*, and for the establishment, acquisition, and equipment of motor omnibuses, trolley buses, and other transport services, and the provisions of tracks and roadways, £100,000;
- (e) for augmenting, improving, and extending the water supply of the city and suburbs, for the improvement and extension of the reticulation of the city, and generally for the purposes of the *Hobart Water Act 1925‡*, £50,000;
- (f) for the purpose of enabling the council to erect houses for occupation by any of the council's employees, and to acquire and take such lands as the council may deem necessary for such purposes, £10,000;
- (g) for the purpose of erecting and equipping a children's clinic in Sandy Bay, in such position as the council shall determine, £2500. Total, £372,500.
