AN ACT to amend the Local Government Act 1962 for the purposes of increasing certain fees and penalties payable under that Act and increasing the maximum amount of the dog tax that may be levied under that Act in respect of certain dogs.

[Royal Assent 30 November 1982]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Local Government Amendment* Short title.
(Miscellaneous Fees and Penalties) Act 1982.

Principal Act.

2—In this Act, the *Local Government Act 1962** is referred to as the Principal Act.

Amendment of section 129 of Principal Act (Minutes).

3—Section 129 (4) of the Principal Act is amended by omitting “ 25 cents ” and substituting “ \$2 ”.

Amendment of section 189 of Principal Act (Procedure for making by-laws).

4—Section 189 (4) of the Principal Act is amended by omitting “ 20 cents for every 100 words ” and substituting “ 50 cents for every page ”.

Amendment of section 214 of Principal Act (Dog tax).

5—(1) Section 214 (2) (*ac*) of the Principal Act is amended by omitting “ \$4 ” and substituting “ \$8 ”.

(2) Section 214 (6) (*b*) of the Principal Act is amended by omitting “ 25 cents ” and substituting “ \$1 ”.

(3) Section 214 (9) of the Principal Act is amended by omitting “ liable to a penalty of \$10 ” and substituting “ guilty of an offence and is liable on summary conviction to a penalty not exceeding \$50 ”.

(4) Section 214 (12) of the Principal Act is amended by omitting “ 25 cents ” and substituting “ \$1 ”.

Amendment of section 328 of Principal Act (Estimates to be open to inspection).

6—Section 328 (1) of the Principal Act is amended by omitting “ 50 cents ” and substituting “ \$2 ”.

Amendment of section 329 of Principal Act (Statements and accounts to be prepared annually).

7—Section 329 (3) of the Principal Act is amended as follows:—

(a) by omitting “ 50 cents ” and substituting “ \$2 ”;

(b) by omitting “ \$1.25 ” and substituting “ \$5 ”.

Amendment of section 773 of Principal Act (Certificate as to rates and charges).

8—Section 773 (1) of the Principal Act is amended by omitting “ 50 cents ” and substituting “ \$5 ”.
