**AN ACT to amend certain Acts by converting penalties expressed in monetary terms to fines and penalties expressed in penalty units**

**[Royal Assent 25 November 1994]**

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**Short title**

**1**—This Act may be cited as the *Statute Law Revision (Penalties) Act 1994*.

**Commencement**

2—This Act commences on the day on which it receives the Royal Assent.

**Amendment of penalties in certain Acts**

3—Each provision of an Act listed in Column 1 of Schedule 1 is amended by omitting the words, figures and symbols specified in Column 2 and substituting the corresponding words and figures specified in Column 3.
