## Appropriation (1979–80, No. 1) Act 1979

## No. 9303

An Act to appropriate certain Sums out of the Consolidated Fund for the Service of the Financial Year 1979-80 and to appropriate the Supplies granted in this Session of Parliament and for other purposes.

[Assented to 30 November 1979]

BE IT ENACTED by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):

Short title.

Application of moneys. \$2 768 939 187. 1. This Act may be cited as the Appropriation (1979-80, No. 1) Act 1979.

2. (1) The Treasurer may issue out of the Consolidated Fund and apply for the services specified in the Table to this section in respect of the financial year 1979-80 the sum of Two thousand seven hundred and sixty-eight million nine hundred and thirty-nine thousand one hundred and eighty-seven dollars.

(2) If—

- (a) during the financial year 1979-80 the amount payable in respect of salaries is increased as the result of any Act or determination; and
- (b) the relevant amounts specified in the Table to this section are insufficient to provide for the payment of the increased amount payable in respect of salaries—

the Treasurer may issue out of the Consolidated Fund and apply for the services specified in that Table such amounts not exceeding in total the

increased

increased amount payable in respect of salaries and any such amounts shall be and be deemed to be appropriated in and towards the service of the financial year 1979-80 in addition to any other appropriation made by this Act.

- (3) In sub-section (2)—
  - "Salaries" includes wages or other payments in the nature of salary, payments by way of overtime or penalty rates or in lieu of long service leave or for retiring gratuities.
  - "Determination" includes any regulation or any award order or determination of a body authorized to determine minimum salaries or wages under any law of the Commonwealth or of the State.

Total amount issued by Acts not to exceed \$2 768 939 187. 4. The total amount that may be issued and applied for or towards the service of the financial year 1979-80 pursuant to this Act and the Supply (1979-80, No. 1) Act 1979 shall not exceed the sum of Two thousand seven hundred and sixty-eight million nine hundred and thirty-nine thousand one hundred and eighty-seven dollars and the amounts to be applied for the services specified in the Table to section 2 for that year pursuant to this Act

shall not exceed the amounts specified in that Table.

Appropriation. \$2 768 939 187. 5. The sums issued and applied by this Act whether expended under this Act or pursuant to the powers conferred by the Supply (1979-80, No. 1) Act 1979 amounting to Two thousand seven hundred and sixty-eight million nine hundred and thirty-nine thousand one hundred and eighty-seven dollars are appropriated and shall be deemed to have been appropriated for the purposes and services expressed in the Table to section 2 in and towards the service of the financial year 1979-80.

Appropriation of Advance to Treasurer. Act No. 9186. 6. The sums set out in the Table to this section have been expended to meet urgent claims out of the Advance to the Treasurer appropriated in the *Appropriation* (1978-79, *No.* 1) *Act* 1978 under Division No. 403 and the payments so made shall be deemed to have been appropriated for the purposes and services specified in that Table.
