An Act to alter the Boundaries of the Electoral District of Belfast. [18th September, 1860.]

WHEREAS by a Proclamation of the Governor of Victoria Preamble.
bearing date the first day of July in the year of our Lord
One thousand eight hundred and fifty-six and published in the *Victoria
Government Gazette* of the eighth day of July One thousand eight
hundred and fifty-six the boundaries of the municipal district of Belfast
were declared to be and defined as follows (that is to say)—
“Commencing at a point on the sea coast being the south-east angle
of section seven parish of Belfast thence by a line bearing north seven
degrees fifty-two minutes west being the eastern boundary of sections
seven eight nine and ten to the southern boundary of section twenty-
four in the parish aforesaid thence by a line easterly being the southern
boundary of sections twenty-four twenty-five twenty-six and twenty-
seven to the River Moyne thence by the western side of the River
Moyne to the Belfast Lough thence by a line south-easterly crossing
the said lough to the northern angle of suburban portion thirty-eight
A in the said parish of Belfast thence by the north-eastern boundary of
the said portion to the sea coast and thence by the sea coast to the
commencing point aforesaid including the islands at the mouth of the
River Moyne” And whereas by clause No. XXXIX. of the
schedule annexed to the 22 Victoria No. 64 intituled “*An Act to alter
the Electoral Districts of Victoria and to increase the number of the Mem-
bers of the Legislative Assembly thereof*” the boundaries of the electoral
district of Belfast were declared and defined as follows (that is to say)
“Commencing at a point on the sea coast bearing south seven
“degrees thirty minutes west sixteen chains twenty-five links from
“the south-west angle of section fifteen township of Belfast and
“bounded on the west by a line bearing north sixty-two chains on the
“north by a line bearing east forty-five chains twenty-five links again on
“the west by a line bearing north three chains seventy-five links to
“the River Moyne by that river to its mouth and by the sea coast to the
“point of commencement also that portion commencing at the south-
“west angle of section A parish of Belfast and bounded on the north-
east

“ east by a line bearing north-west fifteen chains to the Moyne saltwater lagoon by that lagoon and the River Moyne to its mouth and by the sea coast northerly to the last-mentioned point of commencement” And whereas it is expedient that the boundaries of the said municipal district and of the said electoral district should be the same Be it therefore declared and enacted by the Queen’s Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly and by the authority of the same as follows (that is to say)—

Repeal of No. 39 sch.
22 Vic. No. 64.

I. The said recited clause No. 39 of the said schedule annexed to the said Act is hereby repealed.

Boundaries of Belfast.

II. From and after the date of this Act coming into operation the boundaries of the electoral district of Belfast shall be the same as those of the municipal district of Belfast as in the said recited proclamation set forth and defined.

III. This Act shall be read and construed as if it formed portion of the said recited Act And the schedule hereunto annexed shall be substituted instead of the clause No. 39 of the schedule to the said recited Act.

IV. This Act shall commence and take effect from and after the expiration or dissolution of the present Parliament and immediately upon such expiration or dissolution the registrar of the Electoral District of Villiers and Heytesbury shall make out from the general and special electoral rolls for the said district a list of all persons whose qualifications are set forth in the said rolls as being within the “area” comprised within the Electoral District of Belfast as set forth in the Schedule to this Act annexed and shall submit said list and rolls to the justices in petty sessions in the said last mentioned district who shall compare the said list and rolls and certify the said list and the said registrar shall then strike the names on the said certified list out of the roll for the Electoral District of Villiers and Heytesbury and shall forward the said certified lists to the registrar of the Electoral District of Belfast who is hereby authorised and directed to add the names on the said certified list to the roll for the said last mentioned district and such rolls so amended shall be the rolls for the district to which they respectively relate or belong until they are further amended according to law.

SCHEDULE.

THE ELECTORAL DISTRICT OF BELFAST.

Commencing at a point on the sea coast, being the south-east angle of section 7, parish of Belfast; thence by a line bearing north 7 degrees 52 minutes west, being the eastern boundary of sections 7, 8, 9 and 10, to the southern boundary of section 24, in the parish aforesaid; thence by a line easterly, being the southern boundary of sections 24, 25, 26, and 27 to the River Moyne; thence by the western side of the River Moyne to the Belfast Lough; thence by a line south-easterly, crossing the said lough to the northern angle of suburban portion 38 A, in the said parish of Belfast; thence by the north-eastern boundary of the said portion to the sea coast; and thence by the sea coast to the commencing point aforesaid, including the islands at the mouth of the River Moyne
