## **Annual Leave Payments (Amendment) Act 1993**

[Assented to 17 August 1993]

**The Parliament of Victoria enacts as follows:**

### **1. *Purpose***

The purpose of this Act is to amend the **Annual Leave Payments Act 1992** to ensure that it applies to the annual salary loading allowance of members of the teaching service and persons employed in the technical and further education teaching service.

### **2. *Commencement***

This Act is to be taken to have come into operation on 28 October 1992.

**3. Application to certain annual salary loading allowances**

The **Annual Leave Payments Act 1992** is amended as follows:

(a) in paragraphs (a), (b) and (c) of section 1, after “leave” insert “or in respect of the completion of a period of service by members of the teaching service or persons employed in the technical and further education teaching service”;

(b) in section 3—

(i) in the definition of “determination” after “**Public Service Act 1974**” insert “and a Ministerial order within the meaning of Part III of the **Post-Secondary Education Act 1978**”;

(ii) in the definition of “employee” after “**Public Service Act 1974**” insert “, the **Post-Secondary Education Act 1978** or the **Teaching Service Act 1981**”;

(iii) in the definition of “industrial tribunal” after “**Public Service Act 1974**,” insert “the Minister administering the **Post-Secondary Education Act 1978**,”;

(iv) after the definition of “ordinary pay” insert—

“teaching service” means teaching service established under the **Teaching Service Act 1981**;

“technical and further education teaching service” means technical and further education teaching service established under the **Post-Secondary Education Act 1978**.”;

(c) in section 4, after “that employee” insert “or which imposes an obligation on an employer to pay a salary loading allowance to an employee who is a member of the teaching service or to a person who is employed in the technical and

further education teaching service solely in respect of the completion by that member or person of a period of service”;

- (d) in section 5, after “that employee” insert “or which imposes an obligation on an employer to pay a salary loading allowance to an employee who is a member of the teaching service or to a person who is employed in the technical and further education teaching service solely in respect of the completion by that member or person of a period of service”.
