Health Acts (Amendment) Act 1989

[Assented to 21 March 1989]

The Parliament of Victoria enacts as follows:

Purpose

1. The purpose of this Act is to make minor amendments to the *Health (General Amendment) Act 1988*, the *Health Services Act 1988* and the *Mental Health (Amendment) Act 1988*.

Commencement

2. (1) Sections 3, 4 and 5 are deemed to have come into operation on 24 May 1988.

(2) The remainder of this Act comes into operation on the day on which it receives the Royal Assent.

Amendment of *Health (General Amendment) Act 1988*

3. The *Health (General Amendment) Act 1988* is amended as follows: No. 49/1988.

(a) In section 17 (c), for "that source" substitute "that apparatus or source";

(b) In section 40 (2) (c), sub-paragraph (i) is repealed;

- (c) In section 40 (2) (c) (ii)—
 - (i) for “(2)” substitute “(3)”; and
 - (ii) for “(3)” substitute “(4)”;
- (d) In section 42 (c), omit “unless such disposal has been approved”;
- (e) In section 46, for “section 182 (6)” substitute “section 181 (6)”.

Amendment of *Health Services Act 1988*

No. 49/1988.

4. The *Health Services Act 1988* is amended as follows:

- (a) After section 2 (2), insert—

“(2A) Section 199 is deemed to have come into operation on 1 October 1987.”;
- (b) In section 3, in the definition of “Public Advocate” for “section 12” substitute “section 14”;
- (c) In section 50 (2) (c), for “rules” substitute “by-laws”;
- (d) In section 110 (g), for “compensation” substitute “costs incurred”;
- (e) In section 137, for “section 137 (3) (b) or (c)” substitute “section 136 (3) (b) or (c)”;
- (f) In section 169 (2), for “section 171” substitute “section 170”;
- (g) In section 178, in proposed new section 200AB (1) to be inserted in the *Community Welfare Services Act 1970*, for “section 172” substitute “section 176”;
- (h) In section 194, after “*Intellectually Disabled Persons*” insert “*Services*”.

Amendment of *Mental Health (Amendment) Act 1988*

No. 42/1988.

5. After section 2 (1) of the *Mental Health (Amendment) Act 1988*, insert—

“(1A) Section 17 (1) is deemed to have come into operation on 1 October 1987.”.
