# **Hairdressers Registration (Repeal)** Act 1985

[Assented to 10 December 1985]

The Parliament of Victoria enacts as follows:

## Purpose.

1. The purpose of this Act is to repeal the Hairdressers Registration Act 1958.

#### Commencement.

2. This Act comes into operation on 1 January 1986.

## Interpretation.

- 3. In this Act-
  - "Board" means the Hairdressers Registration Board.
  - "Board scheme" means-
    - (a) the Hairdressers Registration Board of Victoria Superannuation Plan; or
    - (b) the Hairdressers Registration Board of Victoria Staff Superannuation Plan No. 33A27-M.

- "State Superannuation Fund" means the Superannuation Fund under the Superannuation Act 1958.
- "Transferred officer" means a person who immediately before the commencement of this Act was an employee of the Board and who by reason of this Act becomes an officer under the Public Service Act 1974.

## Repeal of Hairdressers Registration Act 1958.

4. The Hairdressers Registration Act 1958 is repealed.

#### Transfer of moneys to Consolidated Fund.

5. On the commencement of this Act, all moneys held by or on behalf of the Board immediately before that commencement shall be vested in the Treasurer for the purpose of payment into the Consolidated Fund.

#### Transfer of staff.

6. On the commencement of this Act any person employed by the Board immediately before the commencement of this Act becomes an officer under the Public Service Act 1974 at a salary not less than that which that person was receiving or becomes entitled to receive immediately before that commencement as an employee of the Board and with the classification, emoluments, entitlements and accrued benefits determined by the Public Service Board.

#### Superannuation.

- 7. (1) A transferred officer who immediately before the commencement of this Act was a contributor to a Board scheme shall not become a contributor to the State Superannuation Fund whilst that person continues to be a contributor to that Board scheme.
- (2) A transferred officer who immediately before the commencement of this Act was a contributor to a Board scheme and does not wish to continue to be such a contributor may within one month after the commencement of this Act by notice in writing to the Trustees of that scheme elect to cease to be a contributor to that scheme.
  - (3) A person who makes an election under sub-section (2)—
    - (a) ceases to be a contributor to the relevant Board scheme; and
    - (b) becomes a member of the State Superannuation Fund.
- (4) A person who being eligible to do so does not make an election under sub-section (2) continues to be a contributor to the relevant Board scheme.
- (5) The State must in relation to any person who immediately before the commencement day was a contributor to a Board scheme and who continues to be a contributor to that scheme by virtue of

sub-section (4) make payments to the Trustees of that scheme corresponding to the payments which would have been payable to the Trustees by the Board in respect of that person if this Act had not been enacted.

(6) All amounts payable by the State under sub-section (5) shall be calculated on the basis of the salary from time to time payable to the transferred officer as an officer of the public service.
