An Act to provide, upon the Surrender to Her Majesty of certain Land in the Parish of Yinnar, for the Reservation thereof as a Site for Public Recreation, and for the Revocation of the Reservation of certain other Land in the said Parish temporarily reserved as a Site for Public Recreation, and for the Grant thereof to the President Councillors and Ratepayers of the Shire of Morwell, and for other purposes.

WHEREAS the land described in the First Schedule to this Act is vested in the President Councillors and Ratepayers of the Shire of Morwell :

And whereas the land described in the Second Schedule to this Act was by Order in Council of the Twenty-first day of March One thousand nine hundred and forty temporarily reserved as a site for public recreation :

And whereas the site so temporarily reserved is not large enough or suitable for public recreation purposes :

And

And whereas the President Councillors and Ratepayers of the Shire of Morwell desire to surrender to Her Majesty the land described in the said First Schedule so that it may be permanently reserved as a site for public recreation :

And whereas it is expedient that in exchange for the land so surrendered to Her Majesty the land described in the said Second Schedule should be granted to the President Councillors and Ratepayers of the Shire of Morwell :

Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

1. This Act may be cited as the *Yinnar Lands Act* Short title.

2. Upon the registration in the Office of Titles of a transfer and surrender to Her Majesty of the land described in the First Schedule to this Act freed and discharged from all encumbrances—

- (a) the land so described in the said First Schedule shall be and be deemed to be unalienated land of the Crown freed and discharged from all encumbrances limitations and restrictions whatsoever and from every estate or interest therein ;
- (b) the Governor in Council may pursuant to the Land Acts reserve the land described in the said First Schedule as a site for public recreation and may appoint a committee of management thereof ;
- (c) the hereinbefore recited Order in Council of the Twenty-first day of March One thousand nine hundred and forty so far as it relates to the land described in the Second Schedule to this Act is hereby revoked ; and
- (d) the land described in the said Second Schedule may be granted by the Governor in Council to the President Councillors and Ratepayers of

the Shire of Morwell in fee simple subject to such covenants conditions exceptions and reservations as the Governor in Council thinks fit.

## SCHEDULES.

### FIRST SCHEDULE.

Preamble.

Section 2.

*Land which may be transferred and surrendered to Her Majesty and reserved as a Site for Public Recreation.*

Twelve acres, more or less, Parish of Yinnar, County of Buln Buln, being part of allotment 7; commencing on the southern boundary of a Country Roads Board road at a point bearing S. 88° 50' E. along the said boundary twenty-two chains twelve links from the western boundary of allotment 7; bounded thence by the said road bearing S. 88° 50' E. twelve chains; and thence by lines bearing S. 1° 10' W. ten chains, N. 88° 50' W. twelve chains and N. 1° 10' E. ten chains to the point of commencement.

### SECOND SCHEDULE.

Preamble.

Section 2.

*Land, being the land temporarily reserved by Order in Council of the 21st March, 1940, as a Site for Public Recreation (see "Government Gazette" of 28th March, 1940, page 1395) which may be granted in fee simple to the President Councillors and Ratepayers of the Shire of Morwell.*

Six acres and twenty-five perches, more or less, Parish of Yinnar, County of Buln Buln; commencing at the intersection of the south-eastern boundary of Wicks-street and the south-western boundary of Henry-street; bounded thence by Henry-street bearing S. 65° 28' E. four chains sixty-four and five-tenths links; by allotment 12 bearing S. 0° 18' W. eight chains twenty-three and two-tenths links; by a line bearing N. 89° 40' W. eight chains seventy-nine and two-tenths links; and thence by Wicks-street bearing N. 24° 32' E. eleven chains ten links to the point of commencement.
