## **First Home Owner Grant Regulations 2001**

## 1 Objective

The objectives of these Regulations are—

Reg. 1 substituted by S.R. No. 138/2010 reg. 4.

- (a) to provide that a certain interest is recognised as a relevant interest in land for the purposes of section 5(4) of the **First Home Owner Grant Act 2000**; and
- (b) to authorise the disclosure of protected information to a member of the New Zealand police force for the purposes of section 50 of the **First Home Owner Grant Act 2000**.

### 2 Authorising provision

These Regulations are made under section 54 of the **First Home Owner Grant Act 2000**.

### 3 Definition

In these Regulations—

Act means the First Home Owner Grant Act 2000;

member of the New Zealand police force means a person who is a Police employee within the meaning of the Policing Act 2008 of New Zealand.

## 4 Recognition of interest as a relevant interest in land for purposes of section 5(4)

- (1) For the purposes of section 5(4) of the Act, a person has a relevant interest in land that is owned by another if—
  - (a) the person has—
    - (i) entered into a comprehensive home building contract for the building of a home on that land; or
    - (ii) as an owner builder, commenced building a home on that land; and
  - (b) the owner of the land has granted to the person a licence or right of exclusive occupancy to occupy the home referred to in paragraph (a).
- (2) For the purposes of subregulation (1), the Commissioner must be satisfied that the home—
  - (a) is used or is intended, adopted or designed for use as a separate residence; and
  - (b) has or on completion will have kitchen, bathroom and sanitary facilities.

# 5 Certain persons exempted from joining in applications

If an interest is recognised under regulation 4 as a relevant interest, the owner of the land is not required to join in an application under section 15 of the Act.

### 6 Authorised disclosure of protected information

Reg. 6 inserted by S.R. No. 138/2010 reg. 6.

For the purposes of section 50(4)(d) of the **First Home Owner Grant Act 2000**, protected information is authorised to be disclosed to a member of the New Zealand police force who is also employed at the New Zealand Police National Intelligence Centre, in connection with an
